### Processing of Data

By accessing Our Website the external IP address of your computer as well as http specific information will be stored and logged for statistical, verification and organizational purposes. Our services are designed to be used without indication of any additional personal data. IP addresses are stored for a period of 1 year, after which the data shall be deleted unless a longer time period is necessary for compliance with legal obligations.

Users may, however, indicate their email addresses voluntarily to get notifications in case of any potential technical problems. Such notifications are sent automatically.

## 3. Rights of the Data Subject

! A central aspect of data protection regulations is the implementation of adequate opportunities to allow for the disposition of personal data, even after the processing of said personal data has occurred. For this purpose, a series of rights of the data subject are set in place. Our site shall comply with your corresponding requests to exercise your rights without undue delay and in any event within one month of receipt of the request. Specifically, the following rights are entailed:

! Right to information and access to personal data: should you exercise your right to information, We shall provide

you with all relevant information regarding the processing of your personal data by <https://www.webdollarminingpool.com/>, <https://webd.org>, permitted to the extent of the law. As We are processing very little personal data in order to provide Our services, We may not be able to identify your person by any means. Thus, We may only be able to provide information by requesting additional data to verify your status. This may apply to the other rights of the data subject as well.

- ! Right to rectification: with this right you may request the rectification of inaccurate or incomplete personal data (e.g. email addresses).
- ! Right to erasure: We are obliged to delete personal data (name, email address) upon your request as you may withdraw your consent at any time.
- ! Right to restriction of processing:
  - o restriction may be requested
  - o for a verification period if the accuracy of the data is contested,
  - o if the processing is unlawful.
- ! Right to lodge a complaint with a supervisory authority.

We do not transfer any personal data to third parties without prior explicit consent of the data subject.
